

## NorthWestern Energy E+ Green Motor Rewind Instant Rebate Program Guidelines and Incentive Amounts

Green Motor Rewinds result in the motor maintaining its original efficiency and are only available through Green Motors Practices Members. Instant rebates (End User Incentives) for Green Motor Rewinds are provided on the invoice through a Green Motors Practices Member\*.

### Qualifications

- NorthWestern Energy commercial, industrial, and irrigation electric supply customers are eligible for the program. “Choice” customers, those who buy their electricity through a contract with a competitive supplier, are not eligible. *If you are unsure, please contact us.*
- Instant rebates provided to qualifying NorthWestern Energy electric customers are funded through NorthWestern Energy’s Efficiency Plus (E+) Programs. Pre-approval required.
- Motors 15-5000 Horsepower (HP) are eligible. Motors rewound prior to July 1, 2019 will not be accepted under the program. Projects must be completed by June 30, 2020.

**APPLICATION:** Applications for this program will be completed and submitted by the Green Motor Practices member. NorthWestern Energy customers are advised to retain a copy of the Terms and Conditions and the invoice from the Green Motors Practices member for the green motor rewind. NorthWestern Energy will not be responsible for lost documentation pertaining to this application request. Funds for NorthWestern Energy E+ Green Motor Rewind Instant Rebate (End User Incentives) are limited and available on a first-come, first-served basis. E+ Instant Rebates for qualifying NorthWestern Energy customers are funded through Efficiency Plus (E+) Programs. Details of this program, including incentives, are subject to change without prior notice.

**ELIGIBILITY:** Incentives are available to applicants who are NorthWestern Energy commercial electric supply customers. All projects are subject to review, and receipt of a rebate is not guaranteed. Projects may not receive an incentive if the energy savings does not justify the rebate. "Choice" customers, those who buy their electricity through a contract with a competitive supplier, are not eligible. Final determination of eligibility rests solely with NorthWestern Energy.

**VERIFICATION:** The Green Motors Practices Member will verify that the installed electric saving measures meet program standards. The NorthWestern Energy customer's facility may also be selected for post-installation verification prior to incentive payment. No warranty is implied by this verification. NorthWestern Energy's inspection of installed equipment or energy saving measures is for the sole purpose of assuring that it has been installed and program criteria have been satisfied, and it is not for the purpose of inspecting materials or quality of work. **PAYMENT:** The E+ Instant Rebate is applied to the qualifying NorthWestern Energy Customer invoice from the Green Motors Practices Member.

**PROOF OF PURCHASE:** The invoices from the Green Motors Practices Member must itemize the work performed. This proof of purchase must show: (1) the date of purchase and itemized price paid, (2) the size, type, make, model or part number for the motor and any associated products, and (3) a description of any installation or other labor charges.

**INCENTIVE AMOUNT:** The E+ Instant Rebate is based upon the horsepower of the motor rewound to the Green Motor Practices standard and as set forth in the Program description.

**TAX LIABILITY:** NorthWestern Energy is not responsible for any tax liability imposed on Participant as a result of payment of these incentives.
