

**NorthWestern Energy
E+ Motor Rewind Program
Program Guidelines, Application Instructions and Incentive Amounts**

Qualifications

- NorthWestern Energy commercial and industrial electric supply and small choice customers are eligible for the program.
- NorthWestern Energy large USB Choice customers are not eligible for the program.
- The program is limited to NEMA Premium™, Epact, and standard motor designs “A” and “B” electric motors only.
- This program is for motor rewinds only. For related motor rebate and incentive programs, call (800) 823-5995.
- **NorthWestern Energy representatives may verify completed installations prior to rebate payment.**
- Motors rewound prior to January 1, 2009 will not be accepted under the program.
- This program is for motor rewinds only. Motors placed in stock are not eligible for rebate.
- Eligibility for motors not listed in the attached rebate table must be handled on a site-specific basis. Call (800) 823-5995.
- Details of the program, including incentives, are subject to change without prior notice. Incentive amounts are valid through May 30, 2010.
- **Only motors rewound by qualified Green Motors Practice Group Members qualify for rebates.**
- Motor Rewind Service Centers are eligible for \$1.00 per horsepower incentive.

Steps to Participate

1. Refer to the attached charts for eligible motors and rebate amounts.
2. Complete and sign the NorthWestern Energy E+ Motor Rewind Program application.
3. Attach original or legible copies of the following:
 - Invoice including rewind date, motor manufacturer name, model number, pre-rewind nameplate efficiency, motor type (ODP or TEFC) and horsepower/rpm.
 - Current NorthWestern Energy electric bill for the facility where installation was completed.
4. Submit completed application along with all documentation and current NorthWestern Energy bill.

NorthWestern Energy's inspection of installed energy saving measures is for the sole purpose of assuming that it has been installed and program criteria have been satisfied, and it is not for the purpose of inspecting materials or quality of work. PAYMENT: The incentives will be paid within 4-6 weeks upon: (i) completion of the motor rewind installation, (ii) verification of the installation, and (iii) submission of this completed application with all required information attached.

PROOF OF PURCHASE: The invoices accompanying this application must itemize the products purchased and/or work performed. This proof of purchase must show: (1) the date of purchase and itemized price paid, (2) the size, type, make, model or part number for the products, NEMA nominal full load efficiency, motor type (ODP or TEFC) and horsepower/rpm.

INCENTIVE AMOUNT: Incentives for the rewind motors as set forth in this application are limited to the amounts set forth in this application and may not exceed the purchase price.

TAX LIABILITY: NorthWestern Energy is not responsible for any tax liability imposed on Participant as a result of payment of these incentives.
