COMPETITIVE TRANSITION CHARGE FOR REGULATORY ASSETS

APPLICABILITY: Applicable to all On-System and Transportation Customers, defined below under RATES, for service provided by the Utility.

PURPOSE: The purpose of this Rate Schedule is to recover stranded transition costs which constitute the Fixed Transition Amounts (FTA) Charges for purposes of MCA §69-3-401, et seq. and §69-8-101, et seq.

Core Customer	\$ 0.115 per Dkt (R)
Utility Customer	\$ 0.171 per Dkt (R)
Non-Core Customer	
Post September 1, 1993 Customer	\$ 0.115 per Dkt (R)
Pre-September 1, 1993 Customer	\$ 0.096 per Dkt (R)

Core Customer: The Core Customer rate set forth above shall apply to all end-use, core sales Customer volumes; and volumes of all core sales Customers who elect to convert to transportation service after December 31, 1996.

Utility Customer: The Utility Customer rate set forth above shall apply to those Customers served under Rate Schedule T-FUGC-1 as of December 31, 1996.

Non-Core Customer:

1. The Post September 1, 1993, Non-Core Customer rate set forth above shall apply to the volumes of all Customers who converted to non-core transportation service after September 1, 1993, but prior to December 31, 1996.
2. The Pre-September 1, 1993, Non-Core rate set forth above shall apply to the volumes of all Customers who converted to transportation service prior to September 1, 1993, but shall exclude Conoco and Cenex.

APPLICATION OF RATES:

Monthly Billing: Each month, the FTA Charge shall be the product of the actual monthly quantities of gas delivered at Customer's meter times the applicable rate set forth above.
