

## NorthWestern Energy - Montana Commercial Electric Lighting Rebate Program

**EFFECTIVE AUGUST 1, 2025 – JUNE 30, 2026**

### QUALIFICATIONS

- Incentives are available to NorthWestern Energy commercial electric supply customers. Review the Eligibility section of the Terms and Conditions for additional information. Final determination of eligibility rests solely with NorthWestern Energy.
- Former Energy West Montana and Cut Bank Gas Company customers are currently not eligible for rebate or incentive programs. These customers remain on rates that do not contribute to Demand Side Management (DSM) program funding and therefore cannot receive DSM-related incentives at this time.
- Work completed or materials purchased prior to August 1, 2025, may not be accepted under the program.
- Incentive amounts are valid through June 30, 2026. Details of the program, including incentives, are subject to change without prior notice.
- NorthWestern Energy representatives may verify completed jobs prior to payment.

**APPLICATION:** This application must be filled out completely, truthfully and accurately. Participants are advised to retain a copy of this application and any accompanying documentation submitted to NorthWestern Energy under this program. NorthWestern Energy will not be responsible for lost documentation pertaining to this application request. Funds for incentives are limited and available on a first-come, first-served basis. Details of this program, including incentives, are subject to change without prior notice.

**ELIGIBILITY:** Incentives are available to applicants who are NorthWestern Energy commercial electric supply customers. All projects are subject to review, and receipt of a rebate is not guaranteed. Projects may not receive an incentive if the energy savings does not justify the rebate. Exterior lights included in an "Unmetered Services" line item on a NorthWestern Energy billing statement are not eligible for rebates. "Choice" customers, those who buy their electricity through a contract with a competitive supplier, are not eligible. Final determination of eligibility rests solely with NorthWestern Energy.

**VERIFICATION:** Participant's contractor will verify that the installed saving measures meet program standards and State of Montana codes. Participant's facility may also be selected for post-installation verification prior to incentive payment. No warranty is implied by this verification.
